



Care and Share 50/50 Raffle Rules and Regulations

1. **DESCRIPTION:** Care and Share 50/50 Raffle is a raffle whereby tickets are sold through the YouthQuest Foundation from the date VA OCRP issues the raffle permit until August 5, 2019. Each raffle ticket will cost \$100.00 and the anticipated gross receipts are \$100,000.00. With your support, we will be able to raise more money than ever before, making it possible for us to expand our programs to serve America's at-risk youth.

2. **ELIGIBILITY:** This raffle is only open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older as of the date of entry. To be eligible to win, all information on the raffle ticket must be provided. YouthQuest Board Members and employees and their immediate families and household members, are not eligible to enter or win. Any YouthQuest volunteer that is not a member of the organization can purchase raffle tickets as they are not subject to the rules applied to YouthQuest members. Ticket purchases are not tax deductible.

3. **HOW TO ENTER:** Raffle tickets may be purchased from any YouthQuest Board Member, employee or volunteer.

By entering this raffle, all ticket purchasers agree to follow these contest rules. By accepting the prize, the raffle winner gives us his or her permission (except where prohibited) to use you their name, likeness and statements for publicity purposes without additional compensation including display of their name and image on the YouthQuest website and Social Media. The YouthQuest Foundation is committed to protecting participant's privacy. Therefore, personal information collected will not be traded, rented or sold to third parties.

All entries must be received prior to 3:00 pm August 5, 2019.

4. **DRAWING:** The prize winner will be selected in a random drawing from among all eligible entries received. The odds of winning are 1/total number of entries received. The drawing will be made from a large vessel after thoroughly mixing the tickets and the winning ticket will be pulled from the vessel by a disinterested party.

The drawing will be held at 3:00 pm on Monday, August 5, 2019 at 20391 Lowes Island Blvd, Sterling, VA 20165.

The winner need not be present to win. If absent, the winner will be notified by phone and email if he/she is not in attendance. If the winning ticket holder cannot be reached after a reasonable effort has been made 30 business days from the first notification attempt, the winner will be disqualified, money and all prize funds will revert to The YouthQuest Foundation.

5. **PRIZE:**

A single ticket holder will receive 50% of the net proceeds collected during the raffle ticket sales. Taxes will be the sole responsibility of the winner.

The cash prize will be paid to the winner by check within 30 days of the date the prize is claimed (federal tax withholding may apply).

The designated 50/50 raffle ticket is the only valid receipt for claiming the prize.

6. **GENERAL RULES:** All entries become the property of YouthQuest Foundation and will not be returned. Released Parties (as defined below) assume no responsibility for lost, late, stolen, delayed, damaged, misdirected, undelivered, illegible, incomplete or postage-due entries, or mail. By participating in this raffle, each entrant accepts and agrees (i) to be bound by these Official Rules and the decisions of YouthQuest Foundation, which shall be final and binding in all respects, and (ii) to release YouthQuest Foundation, and its parents, subsidiaries, affiliates, and the respective directors, officers, employees and agencies of the foregoing (collectively, the "Released Parties") from any and all liability of any injuries, losses or damages of any kind caused by participating in this raffle or resulting from acceptance, or use/misuse of the prize. YouthQuest Foundation reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process or the operation of the raffle, violates the Official Rules, or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

7. **COMPLIANCE:** The YouthQuest Foundation has applied for and received Charitable Gaming Permit number G-20-03164-070085 to conduct this 50/50 Care and Share Raffle. The Foundation will comply with all applicable State and Federal Rules and Regulations, including Quarterly and Annual Reporting requirements for this event. 8. **DISPUTES:** Each entrant agrees that: (1) any and all disputes, claims, and causes of action arising out of or in connection with this raffle, shall be resolved individually, without resorting to any form of class action, and any judicial proceedings shall take place in a federal or state court within the state of Virginia.; 2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this raffle, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and YouthQuest Foundation in connection with the raffle, shall be governed by, and construed in accordance with the laws of the State of Virginia, without giving effect to any choice of law or conflict of law, rules or provisions (whether of the State of Virginia, or any other jurisdiction), that would cause the application of the laws of any jurisdiction other than the State of Virginia. IN NO EVENT SHALL YOUTHQUEST FOUNDATION OR ITS RELATED ENTITIES BE LIABLE TO ANY ENTRANT OR WINNER FOR DAMAGES THAT EXCEED THE VALUE OF THE PRIZE TO BE AWARDED TO ANY INDIVIDUAL ENTRANT IN THIS RAFFLE.
